Minutes of the ORDINARY MEETING held on Wednesday 17th January 2018

Open forum

Andy Wainwright (Strategic & Development Manager ERYC) came to talk about Planning Regulations relating to the on-going Wilberfoss quarry application. He talked about the history of the quarry and that this application was centred around the recycling at the site. There has been a voluntary offer of 5k per year to the village and Mr Wainwright explained that this would be part of a legal agreement, managed by Karen Wood of legal dept., and would be available for environment and educational projects etc. Making this offer legal shows probity. The documentation for this is still on-going but should be in place by end February.

The Councillors expressed that they were happy to see that a Liaison Group would be set up and they asked how this would work in practice. Mr Wainwright said that hmself or Matthew Sumner (the application officer) would be happy to chair the initial ones. All agreed that these would help to find common ground when dealing with initial concerns and ensure that the letter of the application would be followed. This will be set up within 2 weeks of the Planning Application being approved. Mr Wainwright said he would arrange a visit to the site, for any interested parties, when the weather was a little better.

Mr Wainwright was asked which agency is responsible for what aspect of

Mr Wainwright was asked which agency is responsible for what aspect of the quarry, with regard to any concerns raised. He said the Planning Department would be the best place to start as they can advise if it is them, Highways or the Environment Agencies responsibility.

The Clerk has been advised by the Wood family that they have put in a request to Highways to provide a turning area opposite their entrance on Back Lane (near Jackson Lane junction). This would entail taking up the grass verge and replacing with a hard surface. This is to assist the lorries when turning into the site. There were no concerns expressed by any Councillor.

Planning Applications:

Land North of Beck Farm, Carr Lane, Newton upon Derwent YO41 5PE ref: 17/03871/PLF Change of use from agricultural land to recreation area in association with existing holiday cottages.

The Council wish to object to the application. There was much discussion about the site. The applicant has submitted planning applications (for a nearby site) previously, that were approved, then amends requested.

The response is below:

This site is situated directly next to the A1079 and a sports/recreation area does not respect the intrinsic character of its surroundings, which are wholly rural farmland.

The PC object to the building of a further stable as the applicant has a newly built one only yards north of this site which is not, currently, being used as a stable.

The Old Coach House (also known as The Squirrels) is where the associated b & b units lie. This site has undergone quite a bit of expansion over the last 5 years, with new built properties but also conversions of existing buildings (garage/gym etc) into b & b units. The concern is that any build on this site (stables/toilet block) would, in time, become additional b & b units as the space becomes fully utilised at The Old Coach House land.
