The Clerk distributed a document showing the current budget and spend against it to date and known costs to financial year end. A draft budget for 2019/20 was discussed and then the Councillors unanimously agreed to keep the precept amount the same as current year (this being £5785.47). As there are more houses in the village this should show as a small drop in charges per household.

Planning Applications:

18/03451/PLF - Land south east of Whitelands Granary, Back Lane, Newton upon Derwent Demolition of agricultural buildings and erection of 3 dwellings. AMENDED PLANS

The applicant submitted amended plans showing access to this site via Main St, in the village centre, rather than access via Back Lane.

The Council expressed their concerns about the number of vehicles that would use the existing entrance right next door to the pub. Their original comments about the site being outside the Local Plan building line and foul water discharge still stand but new comments to add are the concerns on road safety at this exit point if 5 properties have access to use it and the exit via Back Lane should be closed off. They also wished to point out that this entrance on Main St. was never used as a working farm entry/exit point.
